Purpose of the Assessments ☐ North Carolina Final Exams (NCFEs) for Social Studies measure students' academic progress is the NC Essential Standards, adopted by the North Carolina State Board of Education (SBE) in December 2010.
□ NCFEs are not used for school and district accountability under the Accountability Model or fo federal reporting purposes.
Developing Assessments ☐ North Carolina educators are recruited and trained to write new items for the NCFEs. The diversity among the item writers and their knowledge of the content standards are addressed during recruitment. Trained North Carolina educators also review items and suggest improvements, if necessary. The use of North Carolina educators to develop and review items strengthens the instructional validity of the items.
